

Whereas the Colleges & Academic Institute including but not limited to the party of the Second Part selected by NORD for the initiative would be those who are willing to receive & share latest information, training technology & equipment and help NORD in the enhancement of NORD and the bran image, reputation and success of NORD.

PURPOSE AND AIMS

The purpose of this instrument is to recognize the need for cooperation i information sharing / training opportunities for both NORD & BMIT and as well as it some instances, in joint programs for both entities in areas like Gears, Gear Boxes Mechanical, Electrical & Electronic Industrial Drives, Gear Trains and Transmission.

WARRANTIES AND REPRESENTATIONS

Each part waives any claims against the other party for compensation of reimbursement of costs incurred as a result of performance of duties or usage of Loaned Equipment in accordance with this document, including any loss, damage, personal injury or death.

DUTIES OF NORD

- A. Offer a cut section model (herein after called as the Loaned Equipment) of Industrial Gear Box or Geared Motor along with NORD branding & literature.
- B. Conduct a discussion / training / presentation focused on gears, applications, geal unit selections with live examples, question-answer session followed by a brief introduction of NORD group, its India operations, Gear box market and careef growth options pertaining to this industry (for a minimum 60-100 students).



- B. Retain each item of the Loaned Equipment in like condition as received from NORD, normal wear & tear is expected. Title of the Loaned Equipment shall lie with NORD.
- C. Use the loaned Equipment only for the purpose specified in this MOU i.e. training of students of BMIT.
- D. Be the solely responsible for any type of injuries or heath safety related issues arising out of the use of the Loaned Equipment.
- E. Request the written permission of NORD prior to the modification of the Loaned Equipment or transfer of any item of the equipment or complete equipment to third a party.
- F. Not share the details of equipment, parts or equipment as a whole with competitors of NORD.
 - G. Ensure appropriate maintenance and upkeep of the Loaned Equipment.
- H. Organize functions / events so that the initiatives & happenings are known to the students / general public and record the same in appropriate manner.
- Promote the events, happenings & NORD brand using various means of communication like press releases, notice boards, hoardings, college magazines, souvenirs, and brochures, websites, e mails & internet to the best possible.
- J. Agree to indemnify & hold harmless NORD against any and all liabilities, losses, damages, claims and costs incidental hereto as a result of BMIT's use or possession of the Loaned Equipment.

VALIDITY

The agreement is valid for a period of five years with effect from the date signing of the agreement and may be renewed after that period, incorporating mutu agreeable modifications, if any thereafter. Either party may withdraw from agreement by giving a written notice of three months in advance, subject to fulfilling of prior obligations otherwise surviving.

INDEMNITY

Each of the Parties shall indemnify and keep harmless and indemnified the or Party from and against all losses, damages, claims, costs, expenses, compensation liabilities, suits, legal proceedings and otherwise, including reasonable attorney for legal fees and court fees, howsoever arising from any loss caused by the action omission of such Party or in connection with the breach of any terms of this MOII such Party, including but not limited to misrepresentation, fraud, non-delivery etc... any person, entity or third party, whether anticipated, threatened or claimed against other Party. This article shall survive the termination of this MOU.

GOVERNING LAW AND FORUM

All claims regarding this MOU are governed by and construed in accorda with the laws of India, and the courts of Pune, Maharashtra, India shall have exclusive jurisdiction for all disputes pertaining to this MOU.

FORCE MAJEURE

Neither party shall be liable for nonperformance either in whole or in part of t agreement due to reasons unforeseen and beyond its control. These reasons shall inclu and be limited to strikes, lockouts, nationalization, acts of God, war and fire ln t event, the other party will be notified immediately in writing detailing full facts of case and both parties will undertake to arrive at mutually satisfactory solutions overcome the difficulties arising out of these circumstances.

NON-DISCLOSURE

Except in relation to information that is already in the public domain or requi by law, or necessary for the performance of its obligations under this MOU and accordingly disclosed to its respective officers, employees, representatives of age

each Party must not, without the written consent of the other party, directly or indirectly disclose to any other person, use or permit to be disclosed for any purpose other than that contemplated by this MOU, any information that is acquired by it about the other parties affairs under this MOU, or as a consequence of the parties collaboration and must keep all such information strictly confidential and ensure that its officers, employees, representatives and agents keep any such information confidential.

ARBITRATION

NORD and BMIT shall settle any dispute arising out of any clause of this AGREEMENT through mutual consultations. Incase a settlement is not arrived at such dispute(s) will be subjected to provisions of Arbitration & Conciliation Act. The jurisdiction of arbitration shall be the city of Pune.
