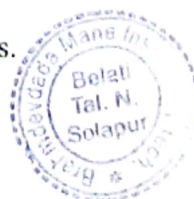

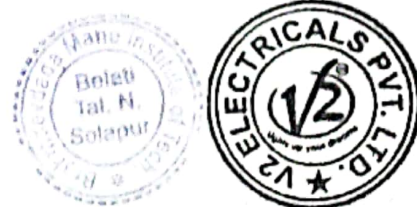
2.0: Role of each party for execution of MOU:


